

# CiraSync Privacy Policy

Last Updated on June 2, 2023

This privacy policy (the "**Policy**") describes the treatment of information provided or collected by Cira Apps Limited (the "**Company**" or "**We**") and on the https://cirasync.com website (the "**Website**"). The purpose of this Policy is to describe how the Website collects, shares and secures information provided by you and our practices for using, maintaining, protecting, and disclosing that information.

This policy applies to information we collect on this website; in email, text, and other electronic messages between you and this website; through our mobile and desktop applications and other non-browser interaction between you and Cira Sync.

This policy does not apply to information collected by: third party websites or API's that may link to or be accessible through the use of our website or products that We do not have control over. Please refer to those third party privacy policies.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our Website or our applications. By accessing or using this Website or using our applications, you agree to this privacy policy. This policy may change from time to time. Your continued use of this Website after we make changes is deemed to be acceptance of those changes, so please check the policy periodically for updates.

We may update the Policy from time to time, so please check in occasionally. Our goal is to provide a Company Policy that is transparent in how we handle your information.

#### 01. Information We Collect

At the Website or through our applications, you may choose to provide the Company with information about yourself which is personally identifiable information. The term personally identifiable information means information that is collected in connection with your name, such as your address, email, phone number, credit card information, and shipment information ("Personal Information"). Your use of the Website or our applications may also entail you providing information that is not Personal Information, meaning that such information is not connected to your name and is, therefore, anonymous information which does not identify and cannot be reasonably used to identify an individual Website user. It is your choice whether to provide us with Personal Information and the provision of such Personal Information is not required when visiting the Website. Therefore, if you provide us with Personal Information, such as by asking to be put on our mailing list, we may contact you from time to time.

Some examples of the types of information we collect are:

• Billing: we collect Personal Information related to transactions and customer accounts. This Personal Information is stored in two places for billing purposes:



- Authorize.NET is a PCI compliant credit card merchant gateway which may store your credit card information. This information is necessary to process refunds. You can read more about Authorize.Net on their website at: https://www.authorize.net/company/privacy/.
- Intuit, a software company that manufacturers QuickBooks. You can read more about Intuit's privacy policy on their website: https://security.intuit.com/privacy/.
- We use OAuth to allow customers to log in without sharing their passwords. You can read more information about OAuth on its website at https://oauth.net. Logins are verified against Azure AD.

#### 02. How We Collect Your Information

- We collect Personal Information from you when you request products, services or information from us, register with us, participate in public forums or other activities on our Website and any platforms which permit us to interact directly with you, respond to customer surveys, or otherwise interact with us. Please keep in mind that when you provide any information to us on a third-party site or platform (e.g., Facebook), that any information you provide may be separately collected by the third-party site or platform. The Personal Information we collect is covered by this Policy and the information the third-party site or platform collects is subject to the third-party site or platform's privacy practices and, therefore, you should familiarize yourself with any applicable third-party privacy policy as needed.
- We do not require the use of cookies. We do not collect or store any data from our site visitors, except when necessary to provide contracted services or to respond to a request for contact. If you submit your Personal Information to us via a form (either to request that we contact you or on landing pages where we offer an asset for download), we may use your contact information to send you promotional emails. You are free to unsubscribe from our communications at any time, and we will respect your request.
- Advertisers and third parties may also collect information about your activity on our Website and on third-party sites and applications using tracking technologies. Tracking data collected by these advertisers and third parties is used to decide which ads you see both on our Website and on third-party sites and applications but does not identify you personally and is not associated with your registration account.
- As you enter our Website, we capture and retain the IP address of the device you are using, such as a personal computer or a mobile device.

#### 03. How We Use Your Information

The Company may use information provided by you on the Website for the following purposes:

- Provide you with the products and services you request.
- Communicate with you about your account or transactions with us and send you information about features on our Website or changes to our policies.
- Consistent with local law and choices and controls that may be available to you:
  - Send you offers and promotions for our products and services or third-party products and services.
  - Personalize content and experiences.
  - Provide you with advertising based on your activity on our Website and on third-party sites and applications.



- Optimize or improve our products, services and operations. CiraSync is a cloud-hosted service that syncs
  Microsoft 365 contacts and calendars to smartphones. It resides in the Microsoft Azure Cloud and is tightly
  integrated with Microsoft 365. For more information about how Microsoft safeguards data, visit https://azure.
  microsoft.com/en-us/support/trust-center/. CiraSync does not move customer data via the Internet. Each server
  is protected with its own firewall. Although CiraSync caches and logs some data to optimize the performance of
  our service, the cache or data logging persists for up to 30 days after which it is purged.
- The Company or Website may use your information to create and/or calculate aggregated statistical information for purposes of improving our services. This data does not contain Personal Information, such as name or email address. An example might be location data or information that might be used to improve our user experience.
- Detect, investigate, and prevent activities that may violate our policies or be illegal.

# 04. Sharing and Disclosure of Your Information

Personal Information about our customers is important to us, and we do not share or sell this Personal Information to others. We share customer Personal Information only as set forth below and with subsidiaries that the Company controls or a parent company of and that are either subject to this Policy or that follow practices that are at least as restrictive as those described in this Policy.

- Internal Process/Employees. Company allows a very limited number of employees to have access to your Personal Information. These employees are trained on our security practices and are deeply committed to maintaining your privacy. They are authorized to access your account information on an as-needed basis to provide technical or billing support, or at your request.
- **Business Transactions and Partner Companies.** Company will never disclose or sell your Personal Information to any third parties, including partners. We will never use client or user information for any purposes other than to provide the contracted services or to keep you apprised of promotions. You are free to unsubscribe from promotional emails at any time. However, opting out of certain free services may also reduce functionality.
- **Exceptions to Sharing Information.** Exceptions to sharing your Personal Information include when the customer provides direct permission, or when it is required by the law or with legal processes.

#### 05. Your Controls and Choices

We provide you the ability to exercise certain controls and choices regarding our collection, use, and sharing of your Personal Information. In accordance with local law, your controls and choices may include:

- You may correct, update and delete your registration account.
- You may change your choices for subscriptions, newsletters and alerts.
- You may choose whether to receive from offers from us and promotions for our products.
- You may choose whether we share your Personal Information with other companies, so they can you offers and promotions about their products and services.
- You may choose whether to receive targeted advertising from many ad networks, data exchanges, marketing analytics, and other service providers.

# **06. Security Measures**

The security, integrity, and confidentiality of your Personal Information is extremely important to us.

We take all commercially reasonable and appropriate measures to secure your Personal Information and have implemented measures designed to secure your personal information from accidental loss and from unauthorized access, use, alteration, and disclosure. All information you provide to us is stored on our secure servers behind firewalls. Any payment transactions will be encrypted and processed using the latest state of the art security technologies.

The safety and security of your information also depends on you. Where we have given you or where you have chosen a password for access to certain parts of our Website or through our applications, you are responsible for keeping this password or login information confidential. We ask you not to share your password or access credentials with anyone. Information you share in public areas may be viewed by any user of the Website.

Unfortunately, the transmission of information via the internet is not completely secure. Although we do our best to protect your personal information, we cannot guarantee the security of your personal information transmitted to our Website or through our applications. Any transmission of personal information is at your own risk. We are not responsible for circumvention of any privacy settings or security measures contained on the Website. Please be aware that, despite our best efforts, no security measures are perfect or impenetrable and, therefore, we cannot guarantee that Personal Information will remain secure in all circumstances.

The core functionality and capability of the application is synchronization of data from one or more sources to one or more targets and thus the information collected and used is integral to the proper functioning of the services provided.
